


AATF History

- Created by the Airport and Airway Development and Revenue Act of 1970 to finance aviation programs
 - Revenues are derived from aviation-related excise taxes on passengers, cargo, and fuel
 - Provides funding for capital improvements to the U.S. airport and airways system
 - Provides the majority of funding for the Federal Aviation Administration
 - 71.12% in FY 2012
 - 71.53% in FY 2013
 - 80.10% in FY 2014
 - 92.77% in FY 2015



Domestic flight segment tax (excluding flights to or from rural airports)	\$4.00 per passenger per segment; indexed to the Consumer Price Index		
Tax on mileage awards (frequent flyer awards tax)	7.5 percent of value of miles		
Tax on international arrivals and departures	\$17.70 per passenger; indexed to the Consumer Price Index		
Tax on flights between the continental United States and Alaska or Hawaii (or between Alaska and Hawaii)	\$8.90 per person; indexed to the Consumer Price Index		
Tax on domestic cargo	6.25 percent on the price paid for transportation of domestic cargo
