The above numbers **DO NOT** include operations and maintenance expenses which are paid directly to an airline owned entity.

- Large III Aircraft** Aircraft with **500,001 lbs or greater** maximum landing weight..
AN-124, B747, B777-300, B777F
- Large II Aircraft** Aircraft with **350,001 lbs - 500,000 lbs** maximum landing weight.
L-1011, MD-11, and DC-10, B777-200LR/ER
- Large I Aircraft** Aircraft with **200,001- 350,000 lbs** maximum landing weight.
B767, B757-300, DC-8
- Medium Aircraft** Aircraft with **100,001- 200,000 lbs** maximum landing weight
B717, B737, B727, MD-88, A-320, C-130, B757-200
- Small Aircraft** Aircraft with **50,001-100,000 lbs** maximum landing weight.
BA-146, Gulfstream II, CRJ-700/900, EMB-170
- Light Aircraft** Aircraft with **50,000 lbs or less** maximum landing weight.

Example: Ramp Use fees are assessed for each 12-hour block of time of occupancy. Therefore, if a B727 were to park for 1 hour the fee would be \$380.00; 11 hours the fee would still be \$380.00. However, if the B727 parked for 13 hours, the fee would be \$760.00 because it has exceeded the 1st 12-hour block and moved into a second block of time. The purpose of parking, whether it is for loading or unloading, just to park, or change crews, is not under consideration.

Non-Signatory Landing Fee \$1.52 per thousand pounds based on *maximum aircraft landing weight*.

Ground Support Equipment Rates and Charges For Common Use Ramps

Effective - 1 Sept 2012

Rate Schedule:

\$0.0212 per square foot occupied by each piece of Ground Support Equipment (GSE)

Policy:

Ramp use fees are assessed for each piece of equipment stored on the common use ramp. Once a month, ATL Airport Operations surveys the common use ramps and inventories the GSE stored on the ramp. The calculations for the GSE are based on the foot print of the item (length multiplied by width), multiplied by the current rate \$0.0212, then multiplied by thirty days. Users are invoiced on a monthly basis.
